Rooted in the politics and theories of early Gay liberation and radical feminism, *The End of Straight Supremacy* presents a cohesive theory of Gay life under straight domination. Beginning with a critique of formal equality law, centering on the "like-straight" demands of liberal equality theory as highlighted in *Lawrence v. Texas*, the book moves to criticize the Gay movement itself, challenging the assimilation politics behind the movement's blithe acceptance of discrimination in the guise of free speech and pornography in the name of sexual liberation, as well as same-sex marriage and transsexualism as tools of straight hegemony. Ultimately, the book rejects both the liberal demand for Gay erasure in exchange for meager legal progress *and* the Gay establishment agenda. In so doing, it provides both the vocabulary and analysis necessary to understand and to resist straight supremacy in all its forms. (An edited version of the final chapter of this book is being translated into Spanish and will appear in an interdisciplinary anthology of writings on gender and sexuality to be published in 2012.)
