In practical terms, it gave law students the chance to learn a journalistic approach to writing, using narrative techniques to develop character, set the scene, and ultimately make their cases more persuasive. And it gave journalism, writing, and documentary film students a rare opportunity to work with an ongoing case of wrongful conviction to learn investigative techniques practiced by lawyers and investigative journalists. The professors were awarded a Mellon grant to prepare for teaching this course in the Spring 2019 and Spring 2020.

This film chronicles the case of Darryl Hunt from the wrongful murder charge in 1984 until his release in 2004. I represented Mr. Hunt from first capital trial in 1985 through appeals and state and federal proceedings until exoneration and pardon in 2004, and in settlement

of his civil claim against City of Winston-Salem in 2007. The film was nominated for the grand jury prize at the Sundance Film Festival and won awards at numerous national and international film festivals, including such prestigious awards as the Columbia School of Journalism Dupont Award (2008). I participated in dozens of panel discussions and presentations at film festivals, law schools, colleges and other venues following screenings of the film, including presentations to the National Innocence Network Conference (2006), the ACLU national conference (2008), the ABA national conference (2009) and the International Association of Chiefs of Police conference (2009).
