V. Executive Summary

Professor George Walker teaches admiralty, conflict of laws, federal jurisdiction, international law and national security law. He joined the Wake Forest law faculty in 1972 and was promoted to professor in 1977; in 2012 he was appointed Dean's Research Professor of Admiralty and International Law. He was appointed Charles H. Stockton Professor of International Law at the U. S. Naval War College, Newport, R.I., for 1992-93. The College faculty and staff were awarded the Navy Meritorious Unit Commendation for excellence, the first in the College's history, for the time while he was Stockton chairholder.

He graduated with Phi Beta Kappa honors from the University of Alabama in 1959, received a Vanderbilt LL.B. in 1966, an A.M. from Duke University in 1968, and an LL.M. from the University of Virginia in 1972. He was a Woodrow Wilson Fellow at Duke, 1962-63, and a Sterling Fellow at Yale, 1975-76. He also holds a diploma with distinction from the Naval War College and a diploma from the National Defense University.

Editor or author of over 20 books and monographs, 60 professional journal articles or book chapters and 30 continuing education chapters, his most recent research includes information warfare, the law of the sea, national security law, maritime neutrality, international civil litigation, federal practice, arbitration, admiralty jurisdiction, and the law of naval warfare. He has also helped draft legislation for international foreign money-claims, family law international commercial arbitration and conciliation for the state courts, state court-ordered legislation and rules, and civil mediation statutes. He was Reporter for the U.S. District Court for the Middle District of North Carolina's Advisory Committee for Implementation of the Civil Justice Reform Act of 1990. He was a mediator in that court's dispute settlement program, a former member of its local rules committee, and a former arbitrator. He was U.S. representative on an international committee that researched and drafted the International Law Association Helsinki Principles on Maritime Neutrality and was reporter for North Carolina Bar Association legislative drafting projects for the North Carolina Revised Uniform Arbitration Act, Family Law Arbitration Act and the Supreme Court of North Carolina's North Carolina Canons of Ethics for Arbitrators. The North Carolina Bar Association International Law & Practice Section presented him with the John J. Dortch Award in 2003 for "distinguished service in international law." He served as reporter for the American Academy of Matrimonial Lawvers Arbitration Committee Model Family Law Arbitration Act (2005) project. The AAML voted him "Special Thanks for Your Exceptional Article" on family law arbitration in 2004. In 2013 the North Carolina Bar Association Dispute Resolution Section gave him its Peace Award, recognizing his "exceptional commitment to peaceful resolution of disputes."

A frequent speaker on law-related topics, he participated in the International Institute of Humanitarian Law panels of experts in Europe and Canada on the law of naval warfare whose San Remo Manual (1995) is the first international compilation of the law of naval warfare since 1913. He chaired the International Law Association (American Branch) Committee on Maritime Neutrality Law, chairs its Law of the Sea Committee, and is a member of its executive committee and board of directors. In 2016 he was elected Honorary Vice President for life. He has also served on ILA international committees on maritime neutrality and oceans baselines.

A retired line Captain in the Navy Reserve, he is a member of the National Defense Executive Reserve with appointment as Counsel to the NATO Interallied Insurance Organization in London.

He is an American Law Institute member for life and has participated in ALI Members Consultative

Groups on the Federal Judicial Code, International Arbitration, and the Restatement (Fourth), Foreign Relations,
